To, The Project Management Unit (PMU) National Dairy Support Project (NDSP or the Project), National Dairy Development Board (NDDB).

Opinion

1. In our opinion and to the best of our information and according to the explanations given to us, except for any effect to the matter described in other matters paragraph, the Project Financial Statements (collectively referred as "the Statements") give true and fair view of the financial position of the Project as at and for the year ended March 31, 2020, in accordance with Note 3 of the Statements. Also in our opinion, the Management of PMU, NDSP ("the Management") has maintained, in all material respects, accounting and internal controls over the financial information submitted by the EIA's selected by us and such accounting and internal controls were operating effectively as of March 31, 2020 based on the criteria described in paragraphs 9.4 and 9.5 of the Project Implementing Plan.

We have audited the accompanying Special Purpose Project Financial Statements of National Dairy Support Project (NDSP), financed by International Development Association (IDA) under Credit/Loan no. IN-5074 and implemented by National Dairy Development Board. These financial statements comprise the Statement of Sources and Application of Funds, the Statement of Reconciliation of Claims to 'I'otal Application of Funds, the Statement of Withdrawal Applications, related Significant Accounting Policies and the accompanying related notes as at and for the year ended March 31, 2020. In accordance with Contract No. PMU/Cons-F/025 dated May 02, 2017 ("the contract") entered with Project Management Unit ("PMU") and its first amendment to the contract dated March 15, 2018 ("the Contract"), the second amendment to the contract is made on March 6, 2019, and third amendment to the contract is made on January 06, 2020, we also have audited the accounting and internal controls of the PMU (as described and set out in paragraphs 9.4 and 9.5 of Project Implementation Plan, dated March 23, 2012, issued by the World Bank) and the accounting and internal controls of the PMU over the financial information submitted by the End Implementing Agencies ("EIAs") Selected by us in consultation with the PMU. The Statements have been prepared by the Management of NDSP's PMU in accordance with the basis of accounting and preparation set out in Note 3 to the accompanying Statements to comply with the Contract.

Basis for Opinion

2. We conducted our audit in accordance with the Standards on Auditing issued by Institute of Chartered Accountants of India (ICAI). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Statements section of our report. We are independent of the implementing agency in accordance with the ICAI's Code of Ethics for undertaking this assignment, and we have fulfilled our ethical responsibilities in accordance with ICAI's Code of Ethics. Emphasis of Matter

3. Without modifying our opinion, we draw attention to note 3 of the Statement, which describes the Basis of Accounting. The PFS is prepared to assist the National Dairy Development Board to meet the financial reporting requirements of the Project/Financing Agreements for Investment Project Financing dated April 13, 2012 in respect of preparation Project Financial Statement in a manner to reflect the operation, resources and expenditures related to the project. As a result, it may not be suitable for any other purpose.

Management's Responsibility for the Statements

4. Management is responsible for the preparation of the Statements in accordance with the basis of preparation set out in Note 3 to the Statements that give a true and fair view of the Statements, laying down and maintaining effective accounting and internal controls in accordance with requirements of paragraphs 9.4 and 9.5 of the Project Implementing Plan. This responsibility include the design, implementation and maintenance of adequate accounting and internal controls that were operating effectively for ensuring the accuracy and completeness of the accounting records relevant to the preparation and presentation of the Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

The Management and those charged with governance are responsible for overseeing the implementing agency's financial reporting process.

Auditor's Responsibility

5. Our responsibility is to express an opinion on the Statement and an opinion on the accounting and internal controls of the PMU, the accounting and internal controls of the PMU over the financial information submitted by such EIAs as aggregated in PMU/Cons-F/025. We conducted our audit in accordance with the Standards on Auditing issued by Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Statements subject to the expenditure covered in Note 3.1 column (b) and (c) are free of material misstatements and whether effective accounting and internal controls was maintained in accordance with paragraphs 9.4 and 9.5 of the Project Implementation Plan.

An audit involves performing procedures to obtain evidence about the amounts and the disclosures in the Statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the Statements, whether due to fraud or error. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the Statements. Our audit of accounting and internal controls included obtaining an understanding of the accounting and internal controls assessing the risk that a material weakness exists, and testing and evaluating the design and operating effectiveness of the accounting and internal controls based on the assessed risk. Our audit also included performing such other procedures as we considered necessary in the circumstances.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

The PMU's accounting internal controls is a process designed to provide reasonable assurance regarding the reliability of financial reporting and the preparation of the Statements for the external purpose in MUMBAI

- accordance with the basis of preparation set out in Note 3 to the accompanying Statements. The Project's accounting and internal control over financial reporting includes those policies and procedures that
- (1) pertains to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and dispositions of the assets of the Statements;
- (2) provide reasonable assurance that transactions are recorded as necessary to permit preparation of statements in accordance with basis of preparation set out in Note 3 to the accompanying Statements, and that receipts and expenditures are being made only in accordance with basis of preparation set out in accordance with authorization of Management of PMU, NDSP and
- (3) provide reasonable assurance regarding prevention or timely detection of unauthorized acquisition, use, or disposition of the PMU's assets that could have a material effect on the Statements.

Because of the inherent limitation of Accounting and Internal Controls, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may occur and may not be detected. Also, projections of any evaluation of the accounting and internal controls over financial reporting to future periods are subject to the risk that the accounting and internal controls over financial reporting may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

Other Matters

6. We did not audit the Fund Utilisation Certificates (FUCs) of certain End Implementing Agencies whose application of funds reflects amount of Rs. 758.81 millions and Rs. 2,795.60 millions of expenditure during the year and as of March 31, 2020 respectively, as included in the Project Financial Statements pursuant to the contract entered with the PMU. These FUC's have been audited by other auditors whose reports have been furnished to us by the management and our opinion/report on the Project financial statements, in so far as it relates to the amounts and disclosures included in respect of these EIA's in so far as it relates to the aforesaid EIAs is bases solely on the reports of other auditors.

Our opinion on the project financial statements is not modified in respect of the above matters since our opinion is solely based upon the work performed by us as mentioned in the Opinion Paragraph.

Other Reporting Matters pursuant to the Contract

- 7. In respect of PMU and EIA' selected and audited by us, and in accordance with the terms of the contract, we report that to the best of our knowledge and belief, and according to the information and explanations given to us:

- (e) the expenditure shown in the Statement are eligible for financing under the legal agreement as referred in the Contract, are recorded in the books of account of the Project and no other sources of Funds have been received by the management for incurring these expenditure;

Notes Forming Part of Project Financial Statements

1. National Dairy Support Project ("NDSP or the Project") / National Dairy Plan Phase I ("NDP-I") is a Central Sector Scheme implemented through a line of credit from International Development Association ("IDA") for a period of eight years from Financial Year 2011-12 to 2018-19.

The Project closing date as per financing agreement between Government of India and International Development Association has been extended to 29 November 2019. There is a grace period of four months for submission of claims to the World Bank and the financial closure of NDP I has been done as at 31 March 2020.

The total outlay of the Plan is ₹22,420 Million comprising of ₹15,840 Million as International Development Association (IDA) credit, ₹1,760 Million as Government of India share ₹2,820 Million as share of End Implementing Agencies (EIAs) and ₹2,000 Million by National Dairy Development Board (NDDB) and its subsidiaries by way of technical and implementation support. The Project is being implemented by the Project Management Unit ("PMU") in NDDB through EIAs.

The Project's Development Objective is to help increase the productivity of milch animals and thereby increase the milk production to meet the rapidly growing demand of milk and to help provide rural milk producers with greater access to organised milk processing sector in project areas.

2. The funds for the project flow from the budget of Department of Animal Husbandry & Dairying (DAHD), Ministry of Fisheries, Animal Husbandry & Dairying, Government of India (GOI) to the PMU in NDDB as grant-in-aid for onward distribution to the EIAs. A separate bank account for receipt of funds and also separate project accounts are being maintained for NDSP/NDP-I as stipulated in the administrative approval issued by the GOI.

3. Basis of Accounting and Preparation:

The policies mentioned hereunder are adopted in the preparation of Sources and Application of Funds Statement (the "Statement").

3.1 The Project Financial Statements have been prepared by PMU in accordance with the provisions of the Contract No. PMU/Cons-F/025 dated 02 May, 2017 and its first amendment to the contract dated March 15, 2018 ("the Contract"), the second amendment to the contract made on March 6, 2019 and the third amendment to the contract made on January 6, 2020

The NDP - I, being a central Government project, accounts are maintained on cash receipts and disbursement basis, under Historical Cost convention and generally accepted accounting practices and standards in India. On this basis funds received from GOI and other receipts are recognised when received rather than when earned, and application of funds are recognised when the amount is spent by End Implementing Agencies or PMU in reporting period and such expenditure is approved by PMU till the time of submission of Interim Unaudited Financial Reports to the Government of India, rather than when the obligation is incurred.

Last Interim Unaudited Financial Report (IUFR) has been submitted for the period October-December 2019 since the World Bank has disbursed the full amount as per the financing agreement. Hence, no further IUFR is required to be submitted to the World Bank. After financial closure of NDP I accounts, GFR 12-A will be submitted to Government of India.

The Project Financial Statement is the aggregate of Source and Application of funds at PMU and EIAs, of which expenditure at PMU and of selected EIAs has been audited by PMU auditor while remaining expenditure at EIAs were either being covered by Regional Auditors appointed by PMU, NDDB or Auditors appointed by respective EIAs.

- 3.2 NDDB appointed Regional Auditors have carried out the audit of expenditures by EIAs for the Financial Year 2019-2020 on quarterly basis till December 2019.
- 3.3 PMU accounts for the funds received from Government of India as and when it is received. The same is disbursed to various EIAs for various approved sub-projects on requirement basis and pending such disbursement, it is kept in bank accounts and short term fixed deposits with SBI.
- 3.4 The Grants to End Implementing Agencies and Centralised Expenditures shown in the Statement includes amount spent on implementation of the approved sub-projects in line with the grant agreements entered with respective EIAs. Amount spent includes capital and revenue expenditures.

Balance with EIAs represents unspent amount out of the grant advanced by PMU.

3.5 PMU accounts for the interest income as and when it is received in bank account of PMU and EIAs.

3.6 Contribution of EIAs towards expenditure under sub-projects in compliance with the approved sub-project plan and unspent balances out of the said contribution are not considered in the preparation of Sources and Application of funds. 3.7 A scientifically planned multi-state initiative on genetic improvement program is launched under National Dairy Plan I (NDP I) to increase the milk production by increasing productivity of milch animals in existing herds through a focused and systematic process of feeding and breeding. Under Progeny Testing, Pedigree Selection and Bull Production through Transfer of Imported Embryos sub-projects, High Genetic Merit (HGM) bull calves have been produced and they were allocated to different semen stations at a rate fixed by expert committee, constituted by DAHD, GOI.

It has been decided to maintain the corpus funds, generated out of sale of bull calves to semen stations, in a central corpus fund account at NDDB. The corpus fund would be utilised for various activities approved by National Steering Committee (NSC).

- **4.** The expenditure reported in the Project Financial Statement are based on the Project books of account and the Fund Utilization Certificates received from various EIAs and approved and accounted by PMU.
- 5. The figures of the previous year have been regrouped wherever necessary.
